Description of the Defect : The A-Frame (drawbars) and safety chains ("Drawbar Assembly") may not meet the Gross Vehicle Weight Rating and could potentially break.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : The Drawbar Assembly has an elevated risk of fracture and full failure while traveling. Should the Drawbar Assembly fracture or fail, the trailer has an elevated increase to cause a crash.

Description of the Cause : When the models were created, the Drawbar Assembly was overlooked by engineering.

Chronology :

On March 24, 2023, During a routine corporate standards inspection of the plant it was found that the incorrectly rated safety chains were being installed. That same day Forest Rivers' Office of Corporate Compliance was notified and began working with the plant to establish the scope of vehicles affected.

On March 31, 2023, Forest Rivers Corporate Recall Committee voted to recall.
A-1

After Forest River's Office of Corporate Compliance ("OCC") filed recall 23V227, OCC was notified on April 10, 2023, that the incorrect A-Frame was also specified. In addition, the improper safety chains were installed onto the vehicle scope since the inception of those vehicles.

On April 11, 2023 OCC filed and amendment to reflect the new remedy and affected vehicles.

A-2 On May 4, 2023 Forest River's Office of Corporate Compliance amended the mail date. The mail date is still within the 60 day period required.

A-3 On June 5, 2023 Forest River's Office of Corporate Compliance amended the recall to reflect all vehicles were at Dealer's therefore no owner letter was issued.

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. The remedy will be to replace the Drawbar Assembly.

How Remedy Component Differs from Recalled Component : The vehicles are now equipped with the correct draw bars and safety chains

Affected Component - A-Frame (drawbars) and safety chains ("Drawbar Assembly") - 2" x 5" x 11GA. Steel Tube A-Frame with 7,600 lbs. rated Safety Chains

Replacement Component - A-Frame (drawbars) and safety chains ("Drawbar Assembly") - 2" x 6" x 11GA. Steel Tube A-Frame with 11,700 lbs. rated Safety Chains

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send

suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
