5/01/23 - Customer commented the seat belt stalks are too short and difficult to engage and disengage . especially when the drivers are wearing gloves, we investigated and sourced a longer stalk to replace the shorter one. There were no failures just a complaint that when we looked into we agreed and decided to recall.

Description of Remedy :

Description of Remedy Program : To replace the shorted stalks with a longer one

How Remedy Component Differs from Recalled Component : The seatbelt buckle will sit higher up and be more accessible

Identify How/When Recall Condition was Corrected in Production : Longer stalks will be fitted in production, we will change out the vehicles already delivered at no cost to the end user, if the end user replaces themselves they can claim back through their dealer.
