The TPP system can only be sold/purchased as "prepped only" until SAF Holland provides permanent remedy/solution for the TPP

system issue before continued use.

Identify How/When Recall Condition Tire Pilot Plus (TPP) tire inflation kits were removed from current was Corrected in Production: production units. Customer wishing to retain the TPP system on their equipment will only be allowed to obtain with equipment "prepped only" for later install of system when final solution is available from SAF Holland. Update - SAF Holland has provided final remedy for this recall. Technical Bulletins from SAF Holland instruct end users how to reactivate & reinstall the Tire Pilot Plus(TPP) system components for proper operation.
