Description of the Defect : 16 specific trailers were manufactured between 2020 and 2022 with formed tongues that do not feature an adequate safety factor and may deform in use and must be replaced. These formed tongues were made with 10 gage steel and not structural steel as before.

Description of the Safety Risk : Trailer tongues may deform in use leading to unsafe road conditions. Deformed tongues may result in unstable travel of the vehicle and lead to loss of control. This causes increased risk of crash or injury.

Description of the Cause : 10 gage formed tongue structural material does not possess adequate safety factor for installed use

Identification of Any Warning that can Occur : Yielding (bending) of the trailer tongue at the front of the enclosure body. Refer to inspection procedure attached.

Description of Remedy Program : safe replacement tongues and labor reimbursement is being provided to customers to refit their equipment.

How Remedy Component Differs from Recalled Component : Remedy tongues are constructed of structural channel iron instead of formed 10 gage sheet metal
