during high stress as described in Dexter recall 22E-080

Description of the Safety Risk: The fractured steer arm and attached tie rod may fail and fall to the ground

causing a risk for separation. There is no loss of control of the unit when this

failure occurs.

This only affects (1) single axle on (1) single trailer. Should this part fail it

will not result in a crash as self-steer capability of the trailer is not

compromised. The tires will wear and the driver will be able to notice per the

warning signs described below.

In the unlikely event that the warning signs described below are not identified the steer arm could potentially come loose and fall to the road. This could potentially cause a crash should a car or other vehicle run over or try to

avoid the part on the road.

Again, this only affects 1 unit and this unit has been serviced per the Dexter
