On August 24, 2023, Forest Rivers Office of Corporate Compliance ("OCC") was notified by the manufacturing plant that it was found during a routine weight check, vehicles were weighing lighter than expected. Upon further inspection, manufacturing plant found a piece of steel had wedged against the scale pad, not allowing the scale pad to be depressed under load.

On August 25, 2023, OCC and manufacturing reviewed manufacturing records, including weights of vehicles.

On September 1, 2023, Forest Rivers Corporate Recall Committee voted to recall.
