On October 9, 2023, the manufacturing plant received a complaint that a fridge had dislodged from its cabinet and fall onto the customer.

On October 11, 2023, Forest River's Office of Corporate Compliance ("OCC") was contacted by the manufacturing plant and made aware of the concern.

On October 13, 2023, OCC met with the manufacturing plant to discuss the concern. It was identified as the only known vehicle which has had the concern to happen.

On October 20, 2023, Forest Rivers Corporate Recall Committee voted to recall.
