On November 1, 2023, during a routine Corporate Standards Audit, it was discovered that the manufacturing plant was installing the incorrect wire gauge between the 50AMP inlet to a transfer switch then to the distribution panel. The same day, the manufacturing plant contacted Forest River's Office of Corporate Compliance ("OCC"). OCC opened a research item.

On November 3, 2023, Forest Rivers Corporate Recall Committee voted to recall.

and Dealers. An authorized Forest River Dealer or Service Center will need to perform the remedy. The incorrect 10-gauge wire will be replaced with

the correct 6-gauge wire.
