**Description of the Defect :** Front seat belt pretensioners were assembled without a rivet securing the quick connector and wire plate.

FMVSS 1 : 208 - Occupant crash protection

FMVSS 2 : 209 - Seat belt assemblies

**Description of the Safety Risk :** Seat belt pretensioners missing a rivet will not properly restrain the occupant in the event of a collision, increasing the risk of injury.

**Description of the Cause :** The installation of the rivet was skipped during assembly.

Honda received the first market complaint for the issue.

September 20, 2023

Honda received the affected parts and began to investigate the issue.

September 27, 2023

Honda investigated the potentially affected population of vehicles.

November 16, 2023

Honda determined that a defect related to motor vehicle safety and a FMVSS noncompliance existed and decided to conduct a safety and noncompliance recall.

As of November 16, 2023, Honda has had 7 warranty claims, and no reports of injuries or deaths related to this issue from April 26, 2022, through November 16, 2023.

## Description of Remedy :

**Description of Remedy Program :** Registered owners of all affected vehicles will be contacted by mail and asked to take their vehicle to an authorized Honda dealer. The dealer will inspect and, if necessary, replace the seat belt pretensioner assembly with a non-defective part.

Owners who have paid to have these repairs completed at their own expense may be eligible for reimbursement, in accord with the recall reimbursement plan on file with NHTSA.

**How Remedy Component Differs from Recalled Component :** The remedy components have rivets installed.

**Identify How/When Recall Condition was Corrected in Production :** The pre-shipping inspection processes were improved.
