**Subject: Automatic Low Voltage Disconnect Switch** 

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler Truck North America LLC (DTNA), on behalf of its wholly owned subsidiary, Thomas Built Buses, has decided that a defect, which relates to motor vehicle safety, exist on certain model year 2021-2023 Thomas Built Buses Saf-T-Liner C2 Jouley electric school buses, manufactured between December 11, 2019, through October 12, 2022.

On the affected vehicles, the automatic low voltage disconnect switch could fail, resulting in a loss of power without warning. This may result in loss of drive power with inability to restart, loss of lights, and loss of power steering, which can increase the risk of a crash.

This is the first of two notices you will receive regarding this subject. This letter is to inform you of an upcoming Recall to correct the issue noted above. Daimler Truck is currently validating the final repair and/or securing replacement parts. **There is no action for you to take at this time**.
