Back-up Lights on certain International® 2001 thru 2003 9100i model trucks, 2001 thru 2010 9200i, 2008 thru 2018 ProStar® model trucks, 2018 thru 2024 RH® Series trucks, 2004 thru 2009, 2011, 2012, and 2016 4400 model trucks, 2013 7600 model trucks, 2023 8100 model trucks, 2002 thru 2007 8500 model trucks, 2003 thru 2018 8600 model trucks, 2001 thru 2007 9400i model trucks, 2003 thru 2007, 2009 thru 2011, 2013 and 2017 9900i model trucks, 2004 and 2007 9900iX model trucks, 2015 thru 2017 LoneStar® Series trucks, 2019 thru 2022 and 2024 LS® Series trucks, 2017 thru 2024 LT® Series Trucks, and 2019 thru 2024 MV® Series trucks with feature code 01WPN, 01WPS, or 01VAL (pintle hook, includes mounting bracket for lowering pintle hook)

DEFECT DESCRIPTION

Certain trucks may not conform to Federal Motor Vehicle Safety Standard (FMVSS) 108 - If any required lamp or reflective device is obstructed by motor vehicle equipment, the vehicle must be equipped with an additional lamp or device of the same type. Specifically, Navistar did not equip these vehicles with additional unobstructed back-up lamps. Back-up lamps that do not conform to all the requirements of FMVSS 108 while in bobtail mode and in reverse with obstructed back-up lamps may increase the risk of a vehicle crash.

REVISION STATEMENT

The suspect population has been expanded and anticipated parts availability has changed.

ELIGIBILITY

This procedure applies ONLY to vehicles marked in the International® Service PortalSM with Safety Recall 23514. Also complete any other open campaigns listed on the Service Portal at this time.

PARTS INFORMATION

This interim service procedure requires no parts.

ACTIONS YOU SHOULD TAKE

Advise your customers and other people that may be driving one of these vehicles to minimize the potential risk of this noncompliance, the operator should exercise greater caution while in bobtail mode and in reverse. The back-up lamp may not be completely visible to following vehicles.

Should a customer call regarding this recall, please ensure they understand the same “Actions You Should Take”, written in the interim notice they received in the mail.

Parts are expected to be available in late-April, 2024.
