General Motors is releasing additional VINs in Safety Recall N232413120-01 today. The additional VINs of U.S. vehicles involved is approximately 123. The bulletin has been revised to include the additional models. Please discard all previous copies of N232413120.

Parts are currently available for the 2013 Buick Verano, 2013 Chevrolet Aveo, Camaro, Sonic and Volt vehicles (Jet Black airbag color only). These vehicles were placed in "Open" status in IVH. This site should always be checked to confirm vehicle involvement prior to beginning any required inspections and/or repairs. Once the service procedure contained in the bulletin has been performed on the vehicle, the vehicle is released from stop delivery and the vehicle can be delivered to the customer.

Parts are currently NOT available for the remaining airbag colors for 2013 Buick Verano or 2013 Chevrolet Volt. These vehicles were placed in "Incomplete – Remedy Not Available" status in IVH on July 27, 2023 and remain on stop delivery until parts are available and the repairs in this bulletin are performed. We anticipate parts availability for the remaining airbag colors in the very near future and will revise this bulletin when parts become available.
