This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Fruehauf Inc. has decided that a defect, which relates to motor vehicle safety, exists in certain 2025 Fruehauf composite Dry Van trailers.

WHY DOES MY VEHICLE NEED REPAIRS?

Trailers equipped with Tire Pilot Plus – Electronic Regulator Control Unit Assembly tire pressure regulation system (TPRS) may experience unintended loss of pressure of all 8 tires while traveling at speeds higher than 45 mph. This can cause reduced vehicle control and/or stability, increasing the risk of a crash. Risk of tire tread separation and debris on the road.

WHAT WILL YOUR DEALER DO?

SAF HOLLAND has an upgrade available that accounts for the above conditions and allows the system to function properly. These upgrade kits will begin to be available effective January 1st, 2024. You can contact your Fruehauf dealer to have this upgrade performed when kits are available or get pre-authorization from Saf-Holland for the upgrade at no cost to you. These upgrades include updated ECU programming and tire hose check valve modifications. The repair will take approximately one hour to complete.

WHAT SHOULD YOU DO?

Please contact your local SAF Holland Warranty Department to initiate the claim process at service@safholland.com or by calling 1-800-767-6967. Additional information is available per XL-AA20131SB-en-US Service Bulletin to assist in identifying which units are impacted and selection of the appropriate reactivation (SRK) kit.
