This notice applies to your REV Ambulance Group Orlando, Inc. (REVO) Ambulance unit with the VIN number(s):

REVO Ambulance vendor component issue, NHTSA recall number: **23V873**.

Dear REV Ambulance Dealer,

This notice is being sent to you in accordance with the requirements of the National Highway Traffic and Motor Vehicle Safety Act. Rev Ambulance Group Orlando, Inc. has decided that a defect which relates to motor vehicle safety exists in a component of certain TriMark's Trip Levers used in Rotary Latches and Cable Brackets.

WHAT IS BEING RECALLED?

Certain V-MUX 8 x 16 I/O Nodes, Weldon Part Number 6030-2000-00 produced between March 10, 2020, and June 14, 2023. Versions 1.00 through 1.02 are affected. Versions 1.03 and newer are not subject to this recall.

WHY IS IT BEING RECALLED?

In the affected products, short circuit protection may not function properly. In the case of a short circuit in the wiring or the connected load, overheating of the wiring or the load may occur, and depending on how the product is installed in the vehicle, this could increase the risk of a vehicle fire.

WHAT YOU AS THE OWNER/OPERATOR SHOULD DO:
