| Issue | Mercedes-Benz AG ("MBAG"), the manufacturer of Freightliner Sprinter Vans, has determined that on certain Sprinter (907 platform) vehicles, the bolted connection of the partition wall might not meet specifications. In this case, a deformation of the partition wall under load could be possible. In addition, an influence on the load securing function cannot be ruled out which could increase the risk of injury in the event of a crash. DVUSA will conduct a voluntary recall. Additionally, given this notice, it is <u>a violation of Federal Law</u> for rental companies to rent new vehicles covered by this notification until the vehicle has been repaired.


