

IMPORTANT SAFETY RECALL

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

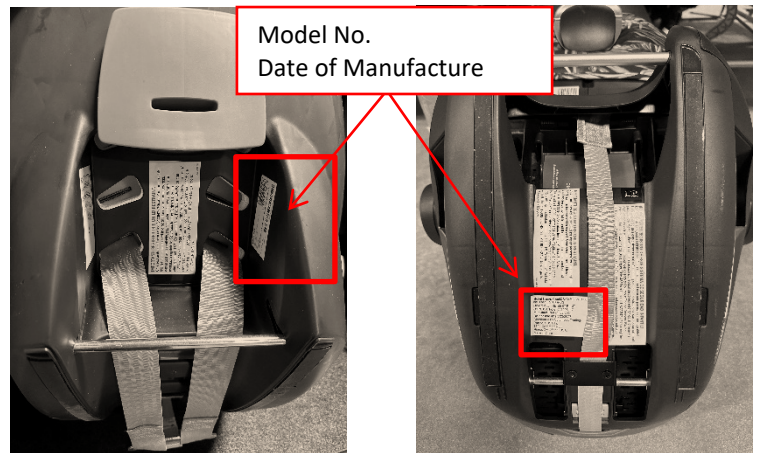
Dear valued CYBEX consumer,

CYBEX and Columbus Trading-Partners U.S., Inc, the U.S. distributor for CYBEX (collectively “CYBEX”) have decided that certain Aton, Aton 2, Aton M, Aton Q, and Cloud Q infant car seats fail to conform to Federal Motor Vehicle Safety Standard Nos. 213, *Child Restraint Systems* and 209, *Seatbelt Assemblies*. Please refer to the table below for specific model details. Our records show that you are a registered owner of a CYBEX infant car seat that is affected.

The affected infant car seats have model numbers listed below and were manufactured **between June 6, 2017 and November 1, 2020**. The model number and date of manufacture are printed on a label on the bottom of the seat.

The front harness adjustment strap used to snugly adjust the shoulder harness straps onto the infant may fray, which can reduce the strength of the front harness adjustment strap. A front harness adjustment strap with insufficient strength may not properly restrain the occupant, increasing the risk of injury in a crash.

CYBEX has included the enclosed remedy kit, free of charge, that includes a replacement front harness adjuster strap assembly and installation instructions for owners. The repair should take 5 minutes. CYBEX urges you to replace the webbing strap assembly currently on your infant car seat with the one provided in the kit, as soon as possible.
