

IMPORTANT SAFETY RECALL

This notice applies to your car seat NHTSA Recall No. 23C002

March 23, 2023

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Dorel Juvenile Group, Inc. in the U.S.A. (DJ USA) has decided all models of Safety 1st onBoard 35 SecureTech and SecureTech infant base as well as Maxi-Cosi Mico XP, Mico XP Max, and Mico Luxe+ and Maxi-Cosi infant base, that include self-retracting lower anchor systems in the base, fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) No. 213 "Child Restraint Systems". The lower anchors used to secure the child seat base may fail allowing the child seat to detach. According to our records, your car seat is affected.

A detached child seat may not properly restrain the occupant, increasing the risk of injury in a crash. DJ USA will send you a free replacement base in approximately 3 months from now. A second letter will be sent to you along with the replacement base when it becomes available. **Until you receive the replacement base, you may continue using your car seat with or without the base when secured <u>using the vehicle belt restraint system</u>, consistent with the existing instruction booklet and labels.**


