**IMPORTANT SAFETY
RECALL NOTICE**

Re: Holt Industries Deluxe Manual Fluid Extractor and Dispenser Recall

NHTSA Campaign I.D. Number: 23E-006

Dear Valued Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Harbor Freight Tools (“HFT”) has decided that a defect which relates to motor vehicle safety may exist in certain Holt Industries Deluxe Manual Fluid Extractor and Dispensers, item number 56384, sold between December 29, 2019, and January 4, 2023. Our records indicate that you have purchased at least one affected product.

What is the condition?

For certain units of the Holt Deluxe Manual Fluid Extractor and Dispenser (Item # 56384), a pressure relief plug may not operate properly under certain circumstances when the product is used in dispense mode and there is a restriction or blockage in the outlet tube. In the event the outlet becomes blocked, the pressure relief plug may not activate, and with continued use in dispense mode, pressure could eventually build enough to cause the lid of the unit to unexpectedly separate from the body of the unit, posing a risk of injury to users and/or property. As a precautionary measure, please stop using the Holt Deluxe Manual Fluid Extractor and Dispenser until after you receive a repair kit and install the replacement parts.

The item number for 56384 can be identified by checking the label on the item.



The affected product also may be identified by checking for the UPC code 792363563840 on the packaging.



All units of the Holt Deluxe Manual Fluid Extractor and Dispenser are subject to this recall.

What will Harbor Freight Tools do?

HFT will provide a repair kit with a component part replacement that the user can easily install. The repair kit will include instructions, a replacement lid ring, and pour spout cap with a new integrated pressure relief valve. It will take approximately 4-6 weeks after HFT confirms your mailing address to receive the repair kit. The repair kit is free of charge.

What should you do?

Even if there is no apparent problem, please immediately stop using the Holt Deluxe Manual Fluid Extractor and Dispenser until Harbor Freight provides you with a repair kit to replace the affected part and further instructions. Reimbursement Information:

The remedy of a component part replacement of the product was not available to consumers prior to this recall.
