

IMPORANT SAFETY RECALL

NHTSA Recall 23E-043

Dear INFINITI QX60 Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Infiniti has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2022 INFINITI QX60 vehicles. Our records indicate that you own or lease the Infiniti vehicle identified by the VIN on the inside of this notice.

If the powered driver's seat cushion assembly on your vehicle was replaced since August 2022, your vehicle may have one of the affected driver's seat service parts included in this campaign.

Reason for Recall Motivo del Retiro

Certain MY 2023 INFINITI QX60 vehicles may have a driver's powered seat that may not be fully secured to the seat frame and the driver's seat frame rail welds may detach from the rear inboard seat bracket. If this condition occurs, it may increase the risk of injury to the occupant in the event of a crash. In addition, in this condition, the seat frame assembly may not meet certain FMVSS 207 "Seating Systems" and FMVSS 210 "Seat Belt Assembly Anchorages" requirements.

What Nissan Will Do Qué Hará Nissan

Your INFINITI retailer will inspect the front driver's seat, and if necessary replace the seat cushion frame. This service, which is conducted at no charge to you for parts and labor, could take up to two (2) hours to complete. However, your INFINITI retailer may require your vehicle for a longer period of time based upon their work schedule.

What You Should Do Qué Debes Hacer

If you notice excess movement in the driver's seat, you should take your vehicle to your local INFINITI retailer for diagnosis. Otherwise, please contact your INFINITI retailer at your earliest convenience in order to arrange an appointment to have your vehicle inspected and if necessary repaired.
