### NHTSA RECALL No. 23E076

This notice applies to your auxiliary fuel transfer system.

Dear [Customer name],

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Transfer Flow Inc. – Chico, CA has decided that a defect, which relates to motor vehicle safety, exists in certain TRAX  $4^{\text{TM}}$  Control Modules with part numbers 070-CM-34418 and 070-CM-34375.

The firmware that controls your auxiliary fuel system may pump fuel into the primary fuel tank and could result in overfilling of the primary fuel tank and associated potential fire risk. If the system engages and begins pumping fuel, it may not stop filling. This condition is because a stationary vehicle's onboard computer system often does not send the appropriate real-time readings as to the primary fuel tank level when the vehicle has not moved since the key was last turned off. This could result in an overfilling of the primary full tank with the possibility of an overflow of diesel fuel occurring, increasing the risk of a fire.

#### WHAT SHOULD YOU DO?

The firmware on the electronic controller needs to be reflashed and updated. This can be achieved by the following methods:

- For a list of local, qualified installers to reprogram the module, call or email Transfer Flow.
- For a live firmware update, call or email Transfer Flow.
- Send your module to Transfer Flow for reprogramming (we will send a prepaid package for you to send us your module free of charge).

The reflash of the controller should take approximately half an hour. This repair will be done free of charge.
