IMPORTANT SAFETY RECALL 23501 NHTSA RECALL NO. 23V-065

This notice applies to your vehicle identified on the enclosed card.

Dear IC Bus Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

IC Bus has decided that a non-compliance which relates to motor vehicle safety exists in certain 2022 thru 2024 CE, and RE, and 2023 EV school bus models built 09/01/2021 thru 01/12/2023.

REASON FOR THIS RECALL

Certain school buses may not conform to Federal Motor Vehicle Safety Standard (FMVSS) 221 – The roof lining joints may not meet the required joint strength pull test requirement.

RISK TO MOTOR VEHICLE SAFETY

In the event of an accident involving the roof of the bus, the roof top sheets may separate and not protect the occupants sufficiently, increasing the risk of possible injury or death.

DEFECT REMEDY

The repair will involve measuring the rivet location for each joint and if they are not within specification, screws will be added to the rear row of rivets to all joints that are out of specification. Dealers have parts and instructions to repair your vehicle. The repair will be performed free of charge and take approximately 30 minutes to 2 hours to complete, depending on your specific bus configuration.

<u>ACTIONS YOU SHOULD TAKE</u>

If you own this vehicle, please schedule an appointment with any IC Bus dealer to have your vehicle repaired. You

If you have already paid for repairs prior to this notice that corrected the defect, you may be eligible for reimbursement of certain repair expenses if they occurred 02/09/2022 thru 04/13/2023. Present your original repair paperwork and proof of payment to any IC Bus dealer and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

If you are the lessor of this vehicle, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

If you do not own this vehicle, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.

IF YOU NEED ASSISTANCE

If you believe that IC Bus has failed to remedy the noncompliance without charge or within a reasonable time, please follow the procedure described in the Owner Assistance Guide section in your Owner's Manual or call toll free 1-800-448-7825.
