#### What is the issue?



The fixed front glass panel between the windshield and the panoramic sunroof may not be properly bonded to the vehicle and may detach. A detached glass panel might become a road hazard, which could increase the risk of a crash.

## What will your Mercedes-Benz Dealership do?



An authorized Mercedes-Benz dealership will replace the front fixed glass panel. This vehicle repair will be provided at no cost to you. While the minimum repair time can be less than 3 hours, your dealership can provide you with a better estimate of the overall time for this service visit.
