

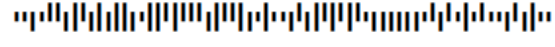

# IMPORTANT SAFETY RECALL

Subject: Safety Recall: 23PBC - Bendix Intellipark recall  
NHTSA: 23V185

Dear Peterbilt Customer,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Peterbilt has decided that a defect which relates to motor vehicle safety exists in certain 2023 to 2024 Model Year 579 tractor chassis built from 07/27/2022 through 02/03/2023 and equipped with the Bendix Intellipark option. The Bendix Intellipark Tractor Park Valve Module (PVM) may intermittently become stuck in the un-parked position and may not transition from un-parked to parked when the park switch is pulled on the vehicle dashboard.

An Intellipark PVM that is stuck in the un-parked position does not allow the vehicle spring brakes to exhaust when the operator pulls the park switch. In order to park the vehicle, the operator must deplete air storage in the air brake system by fanning-down the service brake pedal. If an operator does not properly fan down the brakes, the vehicle may move unexpectedly, which may increase the risk of a crash.

<b>What is the problem?</b>	The Bendix Intellipark Tractor Park Valve Module (PVM) may intermittently become stuck in the un-parked position.
<b>What will your dealer do?</b>	Bendix, the manufacturer of the Intellipark system, will replace the Park Valve Module (PVM) in your chassis listed on this letter with an updated part to address this issue. Bendix will work directly with you to coordinate and perform repairs. Your Peterbilt dealer will not perform this repair.
<b>What should you do?</b>	There is no action required on your part. Bendix will work with you directly to coordinate and perform repairs.

Peterbilt Motors Company has initiated this recall to remedy the issue with no charge to you. Bendix, the manufacturer of the Intellipark system, will replace the Park Valve Module (part number: K171243) with an updated part (part number: K266600R00) in your chassis to address the issue. Bendix will be coordinating and performing all repairs to remedy this issue. The repair will take approximately 1 hour to complete. Your Peterbilt dealer will not perform this repair.
