Dear Valued Customer:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz Sprinter vans and the Jayco motorized division, have decided that a defect which relates to motor vehicle safety exists in certain Model Year (“MY”) 2022 Mercedes-Benz Sprinter vehicles. This includes certain model year (“MY”) 2022 Entegra Coach Qwest Class C motorhomes. Our records indicate that your vehicle is included in the affected population of vehicles.

***Reason for this recall***

Certain Sprinter vehicles equipped with electrically adjustable front swivel-seats, the electrical wiring harness might become damaged when a front swivel seat is adjusted. In the event of a damaged wiring harness, the function of the side airbag installed in the seat back might be impaired. This could increase the risk of injury.

***Recall Remedy***

An authorized Mercedes-Benz dealership will inspect the installation of the wiring harness and will attach it properly. This could take approximately 30 minutes. This service will be provided free of charge.

***What we need you to do***

If you had this Mercedes-Benz recall completed disregard this notice. For additional information and to schedule an appointment, please contact your preferred authorized Mercedes-Benz Sprinter dealer at your earliest convenience. Please mention you are scheduling an appointment to check the swivel seat wire harness routing under Recall Campaign # 2023030003. You may be asked for your 17-digit Vehicle Identification Number (VIN), which for your convenience is located at the top of the letter.

If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.

If you had this repair completed prior to receipt of this recall notice, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
