| <b>What is the issue?</b>                            | On your vehicle, the driver information display may freeze and become disabled upon start-up.                                                                                                                                                                                                                                                                                                           |
| <b>What is the risk?</b>                             | If the driver information display freezes and becomes disabled, then information such as the speedometer, battery charge gauge, and certain indicator lamps and warning messages, as well as acoustic warnings would not be available. This could result in an increased risk of a crash.                                                                                                               |
| <b>What will Lordstown do?</b>                       | Lordstown will update the software on your vehicle to a version that eliminates this issue at no charge to you. The repair is expected to take about 1.5 hours to complete.                                                                                                                                                                                                                             |
