Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that certain Model Year 2022–2023 S-Class, EQE, EQS, and EQS SUV vehicles fail to conform to Federal Motor Vehicle Safety Standard ("FMVSS") Number 305 "Electric-powered vehicles: Electrolyte Spillage and Electrical Shock Protection." Our records indicate that your vehicle is included in the affected population.

What is the issue?



The high-voltage Battery Management System software may not alert the operator of a battery malfunction, which could result in an increased risk of injury. As such, these vehicles fail to comply with the requirements of FMVSS 305.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will update the high-voltage Battery Management System software. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **1 hour**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

Steps to take.



- Find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz Recall Campaign **2023070013**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
