This notice applies to your vehicle identified on the enclosed card.

Dear INTERNATIONAL® Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

**REASON FOR THIS RECALL**

Certain trucks may not conform to Federal Motor Vehicle Safety Standard (FMVSS) 108 - If any required lamp or reflective device is obstructed by motor vehicle equipment, the vehicle must be equipped with an additional lamp or device of the same type. Specifically, Navistar did not equip these vehicles with additional unobstructed back-up lamps.

**RISK TO MOTOR VEHICLE SAFETY**

Back-up lights that do not conform to all the requirements of FMVSS 108 while in bobtail mode and in reverse with obstructed back-up lamps may increase the risk of a vehicle crash.

**DEFECT REMEDY**

The repair will involve replacing existing tail stop/turn signal lamps with tail stop/turn signal lamps with an integrated back-up lamp. Authorized repair locations have parts and instructions to repair your vehicle. The repair will be performed free of charge and take approximately 45 minutes to 1 hour and 20 minutes to complete.

**ACTIONS YOU SHOULD TAKE**

**If you own this vehicle**, please schedule an appointment with any Authorized repair center to have your vehicle repaired at no cost to you. You can find your nearest dealer by using the dealer locator at <https://www.internationaltrucks.com/dealer-locator> or by

**If you have already paid for repairs prior to this notice that corrected the defect**, you may be eligible for reimbursement of certain repair expenses if they occurred 05/18/2022 thru 05/06/2024. **Present your original repair paperwork and proof of payment to any Navistar dealer** and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

**If you are the lessor of this vehicle**, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

**If you do not own this vehicle**, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.
