This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Bugatti Automobiles SAS has decided that a defect, which relates to motor vehicle safety, exists in certain 2022/2023 model year BUGATTI Chiron Super Sport vehicles.

Our records show that you are the owner of a vehicle potentially affected by this safety concern.

What is the issue?	The Chiron Sport RIM type that is currently installed on your Chiron Super Sport is not validated.
	Using these RIMS can have a negative influence on the vehicle airflow and lateral control behaviour in the Top Speed Mode.
