**Certain 2015 through 2023 Model Year Porsche Macan and Panamera Vehicles
Porsche Recall APA9 / NHTSA ID 23V-443**

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect, which relates to motor vehicle safety, exists in certain 2015 to 2023 Model Year Porsche Macan and Panamera vehicles

What is the issue?

Due to an off-line assembly process that has since been corrected, the lower rear outer seat belt anchors on the subject vehicles may not have been tightened to the correct specification. As a result, the lower outer seat belt anchors for the rear seats could come loose over time. If this occurs, the seatbelt anchor could detach from the affected seat, increasing the risk of an injury.

What will Porsche do?

To remedy this issue, Porsche will replace the screw connections to the lower rear outer seat belt anchors on the affected vehicles. This repair should take approximately 1 hour to complete, however, it may be necessary to make your vehicle available to your dealer for a longer period of time. Your Porsche dealer will arrange for alternate transportation if necessary.

What should you do?
The remedy needed to complete this recall is now available.

Please contact any authorized Porsche dealer to schedule an appointment to have this recall performed as soon as possible and to arrange for Porsche-provided alternate transportation, if necessary.
