Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2022–2023 C-Class vehicles. Our records indicate that your vehicle is included in the affected population.

### What is the issue?



The ground connections for the electrical wiring harness may not be secured properly, which can cause higher electrical resistance and lead to the electrical wiring harness overheating. An overheated wiring harness could increase the risk of a fire.

### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will inspect the fastening of the 12V and 48V ground connections and perform repairs, if necessary. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than 4 hours, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other service or repairs unless so requested.

### Steps to take.



- Find your nearest authorized Mercedes-Benz dealer at [mbusa.com/recall](https://mbusa.com/recall) to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz Recall Campaign **2024070016 (CA DMV #240716)**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

**FOR CALIFORNIA ONLY:** A Proof of Correction certificate shall be issued to you by the dealer (California only) showing that the vehicle has been repaired under this Recall Campaign. The certificate may be required by the California Department of Motor Vehicles as a condition of vehicle registration or operation.
