Transmission Electric Oil Pump

This notice applies to your [Model Year] Hyundai [Model] vehicle, VIN: XXXXXXXXXXXXXXXXXXXX

This is an important Safety Recall.

- **The recall remedy is available.** The recall procedure will be performed on your vehicle at **NO CHARGE** to you.
- Failure to complete this recall repair could lead to fire risk.
- Due to fire risk, you are strongly advised to **park your vehicle outside and away from structures** until the recall remedy is completed.

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai has decided that a defect, which relates to motor vehicle safety, exists in **certain 2023 model year Sonata, certain 2023 – 2024 model year Tucson, and certain 2023 – 2024 model year Palisade vehicles**. Hyundai is initiating Safety Recall 246 to repair a condition involving the **transmission electric oil pump** on these vehicles in the U.S. Our records indicate that your vehicle is affected by this recall.

What is the problem?

The transmission electric oil pump for the Idle Stop & Go System (“ISG”) in the subject vehicles might have been assembled with damaged printed circuit boards (“PCB”), which can lead to heat damage to the electric oil pump circuit board, connector, and wiring harness. The heat damage at the pump increases the risk of a vehicle fire in addition to a Controller Area Network (“CAN”) communication disruption for multiple onboard controllers. The electrical heat damage within the electric oil pump assembly increases the risk of a vehicle fire.

What will Hyundai do?

Your Hyundai dealer will inspect and replace the electric oil pump controller, if necessary. This procedure will be performed at **NO CHARGE** to you.

What should you do?

Owners are advised to park their vehicles outside and away from structures until the recall remedy is completed.

Please contact your nearest Hyundai dealer to schedule this procedure.

The actual time required to perform this procedure on your vehicle will take less than one hour, however, your vehicle may be needed longer. To find your Hyundai dealer to schedule an appointment:

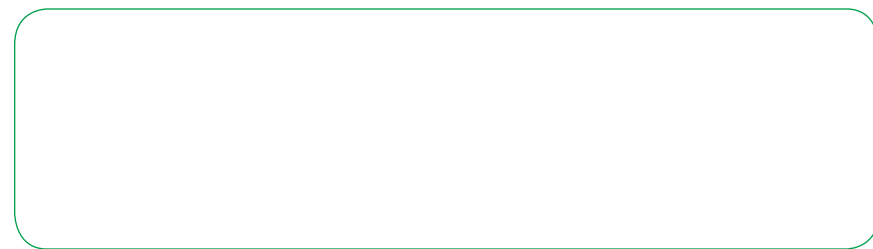
