Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year ("MY") 2023 EQE vehicles. Our records indicate that your vehicle is included in the affected population.



### What is the issue?

The absorbers in the roof frame may not be secured properly and might detach during window airbag deployment. In the event of a crash with window airbag deployment, detached absorbers might strike vehicle occupants and increase the risk of injury.



### What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz dealer will replace the absorbers. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **4.5 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.



### Steps to take.

- Please mention you are scheduling an appointment for Mercedes-Benz Recall Campaign **2023080004**.
