Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2023 GLC300 vehicles. **Our records indicate that your vehicle is included in the affected population.**

### What is the issue?



The tow eye receiver in the front crossmember might not meet current specifications. The front tow eye may be inadequately threaded to the crossmember and can detach under load. A detached tow eye can separate the vehicle from the towing device which could increase the risk of a crash or injury.

### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the front crossmember. **This vehicle repair will be provided at no cost to you.** While the repair time can be **4 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

### Steps to take.

- Please mention you are scheduling an appointment for Mercedes-Benz recall **2023120002**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
