Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a certain model year 2022 EQB350 vehicle fails to conform to Federal Motor Vehicle Safety Standard ("FMVSS") No. 225 (*Child Restraint Anchorage Systems*). **Our records indicate that your vehicle is affected.**

What is the issue?



Incorrect child seat anchor covers may have been installed on the second-row seat. As such, the vehicle fails to comply with the requirements of FMVSS No. 225. The incorrect child seat anchor covers may result in a child restraint system being installed incorrectly, increasing the risk of injury.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the child seat anchor covers. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **30 minutes**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

Steps to take.



- Find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2023100011**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
