Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that certain model year 2019–2021 A-Class, CLA, GLA, and GLB vehicles fail to conform to Federal Motor Vehicle Safety Standard (“FMVSS”) No. 135 “Light Vehicle Brake Systems”. **Our records indicate that your vehicle is included in the affected population.**

### What is the issue?



The vehicles may not be equipped with an inspection gauge to check the wear of the rear brake pads. In addition, information for using this inspection gauge might not be included in the vehicle operator’s manual. Driving with worn brake pads can reduce braking ability, which could increase the risk of a crash.

### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will provide an inspection gauge and supplemental operator’s manual, if necessary, **at no cost to you**. While the overall time can be less than **1 hour**, your dealer can provide you with a better estimate of the total time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

### Steps to take.

- Please mention you are scheduling an appointment for Mercedes-Benz recall **2024010010**.
