Dear Mercedes-Benz Sprinter Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz Sprinter vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2021-2023 Mercedes-Benz Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.



#### What is the issue?

On certain Sprinter vehicles, the chemical composition of the topcoat paint might cause the windows and interior lashing rails to be insufficiently bonded to the vehicle. As a result, the windows might detach which could increase the risk of injury in a crash. In addition, objects secured to insufficiently bonded interior lashing rails could detach, which could increase the risk of injury for vehicle occupants.



### What will your Mercedes-Benz Dealer do?

As a precautionary measure, an authorized Mercedes-Benz Sprinter dealer will check the adhesion of the topcoat paint on the affected vehicles. Depending on the result of that inspection, the window area of the affected vehicles will be stripped, and repainted, and the windows will be reinstalled. If the repair is not feasible, MBUSA will contact you about repurchasing the vehicle.

This could take approximately 12 hours. This service will be provided free of charge. You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.
