Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2024 GLE450e-4Matic Plug-in-Hybrid vehicles. **Our records indicate that your vehicle is included in the affected population.**



### What is the issue?

Due to a software error in the Electronic Stability Program (ESP) control unit, the braking force required to stop the vehicle while driving in electric mode and in certain conditions (such as wet weather), may increase. This could require an extended distance to stop the vehicle, which could increase the risk of a crash.

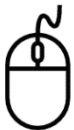
### What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz dealer will update the ESP control unit software. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **1 hour**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.
