Why is a recall being conducted?

2021 through 2023 PILOTCAR LSV may have noncompliance with Federal Motor Vehicle Safety Standard No. 500, because the required Red Rear Side Reflex Markers have not been installed properly.

Vehicles that do not contain the required reflective devices in the appropriate locations may be more difficult for other drivers to see at night, increasing the risk of a crash.

What are we doing about the problem?

If Red Rear Side Reflex Marker replacement or installation is determined to be required, it will be replaced free of charge in about ten minutes, and your vehicle can be driven immediately after the replacement or installation is completed.
