Dear Grenadier Owner,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. INEOS AUTOMOTIVE has decided that a defect, which relates to motor vehicle safety, may exist in certain MY 2024 GRENADIER vehicles equipped with the optional auxiliary switch package relay.

What is the issue?

On the affected vehicles, the relay control wire may have become trapped under the relay power cable connection nut during assembly. This could compromise the insulation of the relay control wire.

What is the risk?

If the relay control wire insulation becomes compromised, an electrical short circuit could occur, increasing the risk of a thermal event or a fire.

What will INEOS and Your Dealer do?

Your INEOS Dealer will inspect the wiring harness and if the relay control wire is trapped or is being clamped, the INEOS Dealer will reroute the cable and repair or replace any damaged control wire sections. The repair will be provided free of charge. The inspection should take approximately 45 minutes to complete. However, due to scheduling, your INEOS Dealer may require your vehicle for longer. Your INEOS Dealer should be able to provide a more accurate repair estimate.

What should you do?

If your vehicle had been inspected for this condition prior to receiving this notice, please disregard this communication.

If not, please contact your local authorized INEOS Dealer to schedule your free inspection as soon as possible.
