Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2021–2022 GLE350 and GLE450 vehicles. **Our records indicate that your vehicle is included in the affected population.**



What is the issue?

A 12-Volt ground connection under the driver seat may not be secured properly, which can cause the ground connection to overheat. An overheated ground connection could increase the risk of a fire.



What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz dealer will inspect the bolt tightness for the ground connection on the affected vehicles and secure it, if necessary. **This vehicle repair will be provided at no cost to you.** While the repair time can be **one hour**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.



Steps to take.

- Find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2023120010 (CA DMV # 231210)**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

FOR CALIFORNIA ONLY: A Proof of Correction certificate shall be issued to you by the dealer showing that the vehicle has been repaired under this Recall Campaign. The certificate may be required by the CA Department of Motor Vehicles as a condition of vehicle registration or operation.

We apologize for any inconvenience this may have caused and look forward to taking care of this important safety recall immediately.
