Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2022–2023 AMG G63 4x4 squared vehicles. **Our records indicate that your vehicle is included in the affected population.**

### What is the issue?



The rear axle differential housing might not meet the strength requirements, and may develop cracks, which can lead to differential oil leaking onto the roadway. In this case, a risk of a crash for following vehicle traffic may be increased. Further, fracturing of the housing could lead to a loss of rear wheel guidance and a loss of drive power without warning. In this case, the risk of a crash or injury could be increased.



**Your vehicle is not safe to drive until a repair is performed! Please have your vehicle repaired immediately! If necessary, towing will be provided free of charge to an authorized Mercedes-Benz dealer and a loaner vehicle can be provided.**

### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the rear axle differential housing. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **2 days**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.
