



## **IMPORTANT SAFETY RECALL**

### **SAFETY RECALL N830: Tail Lamp Inoperative - Water Ingress**

**Vehicles Affected: 2023MY Land Rover Range Rover Sport**

**National Highway Traffic Safety Administration (NHTSA) Recall Number: 23V-871**

**Dear Land Rover Owner:**

This notice is sent to you in accordance with the *National Traffic and Motor Vehicle Safety Act*. Land Rover has decided that a defect which relates to motor vehicle safety exists in certain 2023MY Range Rover Sport vehicles.

Your vehicle is included in this Recall action.

Land Rover previously wrote to you on February 08, 2024, to advise your vehicle is affected by this recall but that parts were not available for repairs. This second letter confirms that required parts are now available and service appointments can be made.

#### **What is the reason for this program?**

The right-hand tailgate and body mounted rear lamps may experience water ingress leading to one or more lamp failures including loss of brake/stop lamp, outer marker lamp, reversing lamp and direction indicator/turn indicator.

Exterior lights that fail to illuminate can decrease visibility and increase the risk of a crash.

#### **What are the warning signs of this condition?**

Customers could see a loss of rear right hand lamp system functionality.

#### **Are there any precautions that may be taken to minimize the safety risk until the corrective measures are implemented?**

Until such time as the recall has been completed, customers are advised to regularly check the operation of their rear lamps and if they fail to function as expected or differ from the operation of the left-hand side, seek retailer assistance.

#### **What will Land Rover and your authorized Land Rover Retailer do?**

The right-hand tailgate and body mounted lamps will be replaced. There will be no charge to the owners for this repair.

#### **What should you do?**

Please contact your preferred authorized Land Rover retailer and provide them with your Vehicle Identification Number (VIN) and request a service date to complete the work required under Program Code 'N830'.

**Attention Leasing Agencies:** If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within TEN (10) days.

**How long will it take?**

The work will be carried out as quickly and efficiently as possible in order to minimize any inconvenience to customers and is expected to take up to approximately one (1) hour although your retailer may need your vehicle for a longer time. Your retailer can provide you with a better estimate of the overall time for the service visit.

**What if I have previously paid for this concern?**

If you have already paid for this concern before the date of this letter, Land Rover is offering a refund. To qualify for a refund, please provide your authorized Land Rover retailer with the original paid receipt.

To avoid delays, please do not send the receipt to Jaguar Land Rover North America, LLC.

**Moved or no longer own this Land Rover vehicle?**

If you are no longer the owner of this vehicle, Land Rover would appreciate the name and address of the new owner (if known); please fill out and return the enclosed return postage-paid card.


