This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz Sprinter vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2020 Mercedes-Benz Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the issue?



On certain Sprinter vehicles, the strength of a crossmember at the body-in-white might not meet specifications. The bolt connection of the propeller shaft bearing on the crossmember might loosen over time, which could reduce vehicle control, increasing the risk of a crash. In addition, in the event of a crash, the propeller shaft might damage the fuel tank and result in a fuel leak, increasing the risk of fire.

What will your Mercedes-Benz Sprinter Dealer do?




An authorized Mercedes-Benz Sprinter dealer will inspect the crossmember and replace it, if necessary.

This could take approximately 1 hour. This service will be provided **free of charge**. You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.

If you have already paid to have this recall condition corrected, you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.

- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check or copy of credit card receipt).
- Reimbursement will be made by check from your dealer. If your claim is denied you will receive a letter from MBUSA within 60 days of receipt with the reason(s) for the denial.
