Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2023 GLC300, and 2024 GLE350 and GLE450 vehicles. **Our records indicate that your vehicle is included in the affected population.**



What is the issue?

Incorrect screws installed on the high-pressure fuel pump may prevent a proper seal between the high-pressure fuel pump and the tandem oil pump. An inadequate seal can allow fuel and oil to leak onto the road, creating a hazard for other road users and increasing the risk of a crash. Additionally, a fuel and oil leak in the presence of hot engine components can increase the risk of a fire. When the issue occurs, the driver might notice the illumination of the Malfunction Indicator Lamp (MIL) in the instrument cluster.



What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz dealer will replace the high-pressure fuel pump. **This repair will be provided at no cost to you.** While the repair time can be **five hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.



Steps to take.

- Find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2024010008**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
