### **Subject: High Voltage Junction Box Inverter Cable**

This notice is sent to you in accordance with the requirements of the *National Traffic and Motor Vehicle Safety Act*.

Daimler Truck North America LLC (DTNA), on behalf of its wholly owned subsidiaries, Freightliner Custom Chassis Corporation (FCCC) and Thomas Built Buses (TBB), has decided that a defect, which relates to motor vehicle safety, exists in certain model years 2021-2025 FCCC MT50E chassis and TBB Saf-T-Liner C2 Jouley electric school/commercial buses, manufactured between December 11, 2019, and October 18, 2023. See below for additional detail on vehicle applicability:

On the affected vehicles, fasteners at the joint connecting the high voltage inverter cable to the associated junction box hardware may not have been secured properly, which could lead to loss of drive power without prior warning, increasing the risk of a crash.

A Daimler Truck North America authorized service facility will repair the affected vehicles by inspecting and tightening the fasteners. The recall will take approximately one hour and will be performed **free of charge**.

You may be liable for any progressive damage that results from your failure to complete the recall within a reasonable time after receiving notification.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner. If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within 10 days. If you are a subsequent stage manufacturer, Federal law requires that you forward this notice to your distributors and retail outlets within five working days. If you have paid to have this recall condition corrected prior to this notice, you may be eligible to receive reimbursement. Please see the reverse side or final page of this notice for details.

## **Reimbursement to Customers for Repairs Performed Prior to Recall**

If you have already **paid** to have this recall condition corrected you may be eligible to receive reimbursement.

Requests for reimbursement may include parts and labor. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Daimler Truck North America LLC dealer. The following documentation must be presented to your dealer for consideration for reimbursement.

Please provide original or clear copies of all receipts, invoices, and repair orders that show

- The name and address of the person who paid for the repair
- The Vehicle Identification Number (VIN) of the vehicle that was repaired
- What problem occurred, what repair was done, when the repair was done
- Who repaired the vehicle
- The total cost of the repair expense that is being claimed
- Proof of payment for the repair (such as the front and back of a cancelled check or a credit card receipt)

Reimbursement will be made by check from your Daimler Truck North America LLC dealer.
