

Dexter Axle U-Bolt Torque Inspection and Repair

- When performing warranty or recall service, please make certain that appropriate Personal Protective Equipment (PPE) is used.
 - The remedy is to torque the axle U-bolt nuts in a cross pattern to 110 ft lbs.
- 1. Locate the trailer on a level, flat, hard surface. Chock the wheels.
- 2. Follow the Dexter instructions below.

MATERIALS: Wood blocks or wheel chocks, click torque wrench, road cones, and safety equipment including: safety glasses, cut resistant gloves, and steel-toed shoes.

3) Torque Fasteners (RE-TORQUE)

Using click torque wrench, apply specified torque to fasteners in sequential criss-cross pattern as shown. *APPLY TORQUE WITH AXLE INSTALLED AND IN LOADED STATE*
