- 1.1. Park the vehicle on an even surface with the transmission on neutral.
- 1.2. Apply the parking brake and set the master control switch to the *stop* position.




Figure 1 - Emergency Exit Stickers to Remove

- 1.3. With a plastic scraper and isopropyl alcohol, remove all the emergency exit stickers from both rear emergency exit windows locate above the rear axle. See Figure 1.
