SUBJECT: TRUNK LATCH SUB ASSEMBLY REPLACEMENT (SC278)					

This bulletin provides information to replace the trunk lid latch sub assembly on the following vehicles listed on page 3. A crack can develop in the pawl of the trunk latch base subassembly which can intermittently cause the trunk's interior emergency release lever to be inoperative. As a result, the subject vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) 401, "Interior Trunk Release". In the rare event that a person is inside the trunk compartment at the same time the latch pawl cracks, the person may not be able exit the trunk, thereby increasing the risk of injury. Follow the procedure outlined in this publication to replace the trunk lid latch sub assembly on the applicable vehicle. Before conducting the procedure, verify that the vehicle is included in the list of affected VINs.



There is no charge to the vehicle owner for this repair. Under applicable law, you may not sell or otherwise deliver any affected vehicle until it has been repaired pursuant to the procedures set forth in this bulletin.

Repair status for a VIN is provided on KDealer+ (Service \rightarrow Warranty Coverage \rightarrow Warranty Coverage Inquiry \rightarrow Campaign Information). Not completed Recall / Service Action reports are available on KDealer+ (Consumer Affairs \rightarrow Not Completed Recall \rightarrow Recall VIN \rightarrow Select Report), which includes a list of affected vehicles.





Replacement Procedure:

 Remove the trunk lid latch assembly (A) by referring to "Body (Interior and Exterior) → Trunk Lid → Trunk Lid Latch → Repair procedures" in the applicable Shop Manual on KGIS.


<u>Note</u>: Be sure to replace any damaged clips from the trunk lid trim during removal.






2. Loosen the four (4) mounting screws (B).

<u>Note</u>: The bottom left screw is different than the other three (3). It is partially threaded with a long shank.



3. Separate the latch base sub assembly (C) from the latch actuator assembly (D).

The latch actuator assembly (D) will be <u>reused</u>.


TRUNK LATCH SUB ASSEMBLY REPLACEMENT (SC278)

 Reassemble the trunk lid latch assembly (A) by attaching the trunk latch actuator (D) to the new latch base sub assembly (C).

> <u>Note</u>: The bottom left screw is different than the other three (3). It is partially threaded with a long shank. When installing new part, ensure the correct screws are installed in the appropriate locations.

IMPORTANT

Be sure to not let any foreign material adhere to the terminals (E) between the new sub base assembly (C) and latch actuator assembly (D).



- 5. Reinstall all removed parts in reverse order of removal.
- 6. Confirm that the trunk lid latch assembly (A) operates normally when opening and closing the trunk.
