SAFETY RECALL CAMPAIGN

HECU MULTI FUSE REPLACEMENT (SC284XM)

This bulletin has been revised to include additional information. New/revised sections of this bulletin are indicated by a black bar in the margin area.

This bulletin provides information to replace the multi fuse of the Hydraulic Electronic Control Unit (HECU) and install an updated junction box label on certain 2011-2014MY Sorento (XMa) vehicles produced from March 3, 2010 through June 14, 2013. An engine compartment fire may occur in the area where the HECU is located. The HECU may experience an internal electrical short circuit condition that can result in overcurrent, thereby increasing the risk of an engine compartment fire while the vehicle is driven or while parked. Dealers are to install new fuses to prevent an electrical short circuit condition in the HECU's electrical circuit board. Customers may experience Illumination of the Malfunction Indicator Lamp (MIL), ABS warning light, burning/melting smell, and/or smoke from the engine compartment. Follow the procedure outlined in this publication to install a new multi fuse and junction box cover label on the applicable vehicle. Before conducting the procedure, verify that the vehicle is included in the list of affected VINs.

There is no charge to the vehicle owner for this repair. Under applicable law, you may not sell or otherwise deliver any affected vehicle until it has been repaired pursuant to the procedures set forth in this bulletin.

Repair status for a VIN is provided on KDealer+ (Service \rightarrow Warranty Coverage \rightarrow Warranty Coverage Inquiry \rightarrow Campaign Information). Not completed Recall / Service Action reports are available on KDealer+ (Consumer Affairs \rightarrow Not Completed Recall \rightarrow Recall VIN \rightarrow Select Report), which includes a list of affected vehicles.

SUBJECT:

HECU MULTI FUSE REPLACEMENT (SC284XM)

Replacement Procedure:

- 1. Open the hood.
- 2. Disconnect the negative (-) battery terminal.
- 3. Remove the junction box fuse cover.


- Locate the Multi Fuse (A) for ABS1 and ABS2 and loosen the two (2) 10mm Multi Fuse retaining nuts (B) and remove the Multi Fuse.
- 4b. Install the <u>new</u> Multi Fuse (A) and tighten the two (2) retaining nuts (B).



Tightening torque for retaining nut (B): 7.2 - 8.7 lb.ft (9.8 - 11.8 N.m)

Note: Drill a hole through the center of the removed Multi Fuse. <u>DO NOT reuse.</u>

5. Adhere the new ABS1 '30A' and ABS2 '30A' fuse labels to the bottom of the junction box fuse cover, as shown.

6. Reinstall all removed parts in reverse order of removal.
