AND REPLACEMENT (SC289) This bulletin provides information to inspect and, if necessary, replace the curtain air bag (CAB) module(s) on certain 2023MY Soul (SK3), vehicles manufactured from April 3, 2023 through May 15, 2023, and certain 2024MY Seltos (SP2) vehicles manufactured from April 3, 2023 through May 15, 2023. Due to a welding error in the stored gas section of the hybrid inflator, the side curtain airbag may inflate inadvertently without a deployment command from the Airbag Control Unit (ACU). The inadvertent inflation of the side curtain airbag

increases the risk of injury to an occupant and may also create a driver distraction increasing the risk of a crash. Follow the procedure outlined in this publication to inspect and, if necessary, replace the affected module(s) with a new one. Before conducting the procedure, verify that the vehicle is included in the list of affected VINs.



There is no charge to the vehicle owner for this repair. Under applicable law, you may not sell or otherwise deliver any affected vehicle until it has been repaired pursuant to the procedures set forth in this bulletin.

Repair status for a VIN is provided on KDealer+ (Service \rightarrow Warranty Coverage \rightarrow Warranty Coverage Inquiry \rightarrow Campaign Information). Not completed Recall / Service Action reports are available on KDealer+ (Consumer Affairs \rightarrow Not Completed Recall \rightarrow Recall VIN \rightarrow Select Report), which includes a list of affected vehicles.

SUBJECT: CURTAIN AIRBAG MODULE INSPECTION AND REPLACEMENT (SC289)

Inspection Procedure:

- 1. Disconnect the 12V battery negative (-) cable.
- Detach the top of the left driver side front door side weatherstrip (A), <u>along the A-Pillar and</u> roof area.
- 3. **Partially** detach the A-front pillars on both left and right side as shown.
- 4. Repeat steps 1-2 for the right passenger side.



 Locate the curtain airbag barcode label and note (write down) the first 8 digits of the LOT number of both CAB modules.

Note: The left side may require to be pulled and twisted to view the label.

- Using KVID, take a continuous clear video starting from the VIN label and clearly displaying the two (2), left and right side CAB module LOT numbers and submit it with claim.
- On a computer/tablet: Go to KGIS by selecting the link: TBD









- 8. Enter the applicable LOT numbers (Left and Right side) in the table shown to verify if one, both <u>or</u> none of the curtain airbags modules require replacement.
- 9. If the result is OK, reinstall all removed parts in the reverse order of removal. No further action is required.
 - If the result is NG for the left and/or right curtain airbags, then proceed to the replacement procedure outlined on page 3.

Repair Procedure:

 <u>Carefully</u>, remove the roof trim assembly (A) by referring to "Body (Interior and Exterior) → Roof Trim → Repair procedures" in the applicable Shop Manual on KGIS.

Be careful not to stain, twist, bend or damage the headliner (roof trim assembly) in any way or form while performing the procedure.





Replace the applicable NG (left <u>and/or</u> right side) curtain airbag module (B) with a new part by referring to "Restraint → Airbag Module → Curtain Airbag (CAB) Module → Repair procedures" in the applicable Shop Manual on KGIS.

IMPORTANT

Be sure to replace any existing clips/fasteners with new parts provided in the CAB kit.

- 3. Reinstall all removed parts in the reverse order of removal.
- 4. Confirm normal vehicle operation.

After completing the installation of the new curtain airbag, the SRS indicator light will turn 'ON' for about six (6) seconds and then shut 'OFF'
